YAMA TERMS & CONDITIONS

- All footage used is to be original and is to be accompanied by a completed 'Release Agreement' form for all productions. A copy of the 'Release Agreement' form can be downloaded at www.yama-award.com. It is the applicant's responsibility to obtain all appropriate permissions & clearances for any music used. JMI excludes liability for any law violations. Sole responsibility for this lies with the producers of the content.
- All videos must be filmed by one static (unmoving) camera only. Productions must be filmed from the front of the performance aka 'head on'.
- Entries will not be limited in duration. However, the 5 videos chosen as finalist will be shorted in length to 3mins each to present online for public vote.
- Entries are to be submitted to the competition as a DVD (Please contact us if you have problems meeting this requirement).
- For productions not in English, subtitles are requested, where possible.
- All DVD entries should be mailed to JMI (Rue Baron Horta 13, 1000 Brussels, Belgium).
- Entries are to be received no later than 5pm on the closing date, 1st May 2010. Accompanied by all appropriate paperwork.
- JMI accepts no responsibility for late or misplaced entries.
- On the 1st of August, the jury will select 5 finalists who will be notified by email.
- Decisions of the jury are final and are not subject to questions, revisions or appeal.
- In August 2010 the 5 finalists' videos will go online at the site www.yama-award.com, where they will be open to public vote.
- The YAMA Awards Ceremony, will be held in Skanderborg, Denmark in October 2010.
- Prizes are not negotiable and non-transferable.
- Prizes will be awarded to the nominated production, to support the creation of new works for young audiences.
